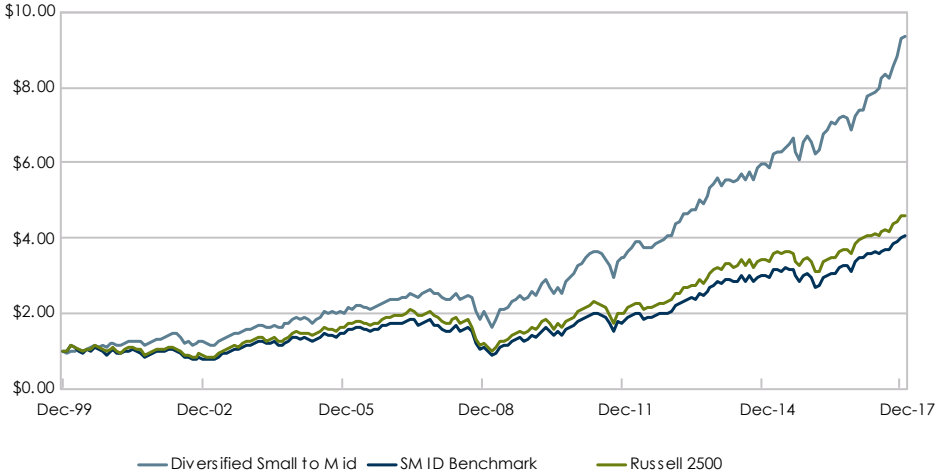

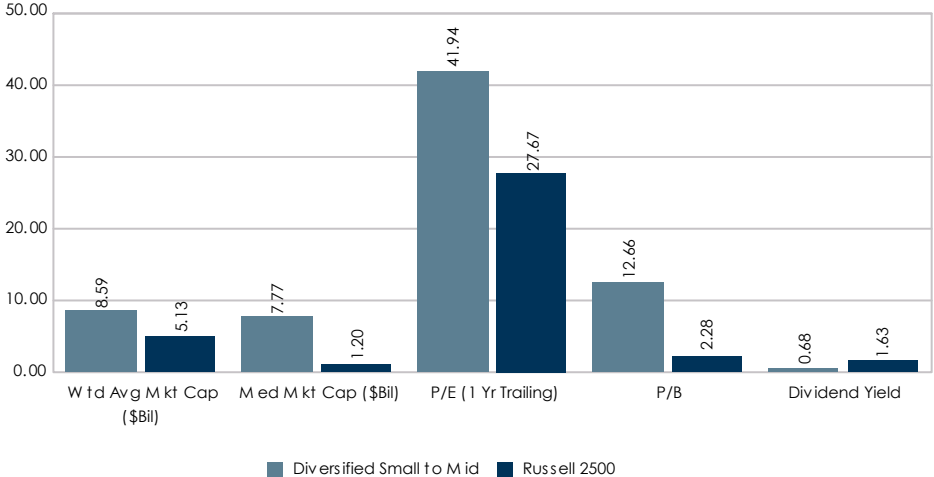

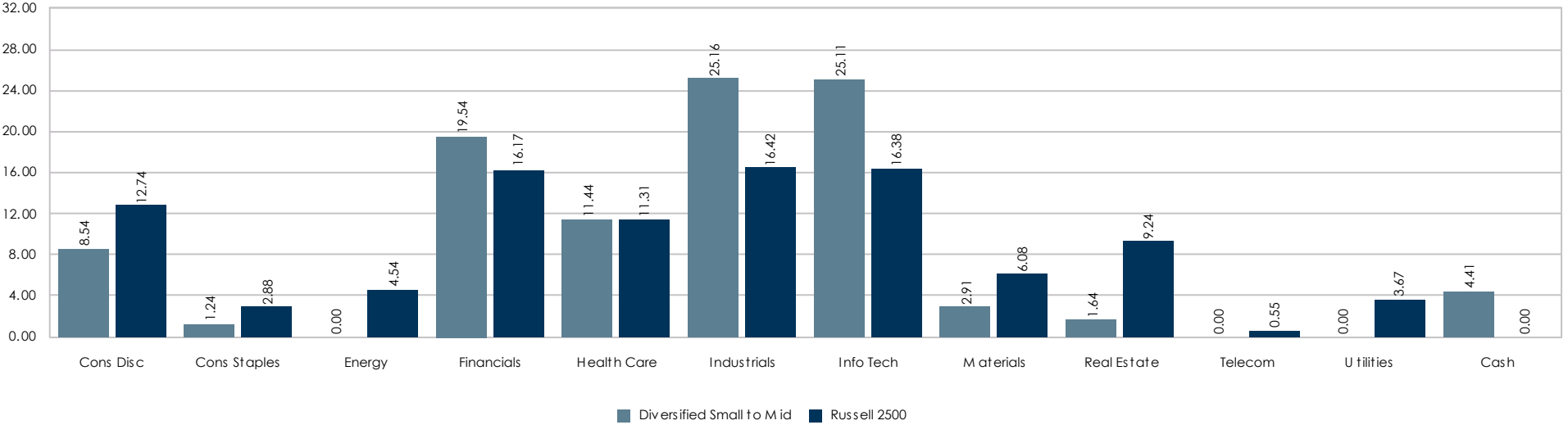
Growth of a Dollar

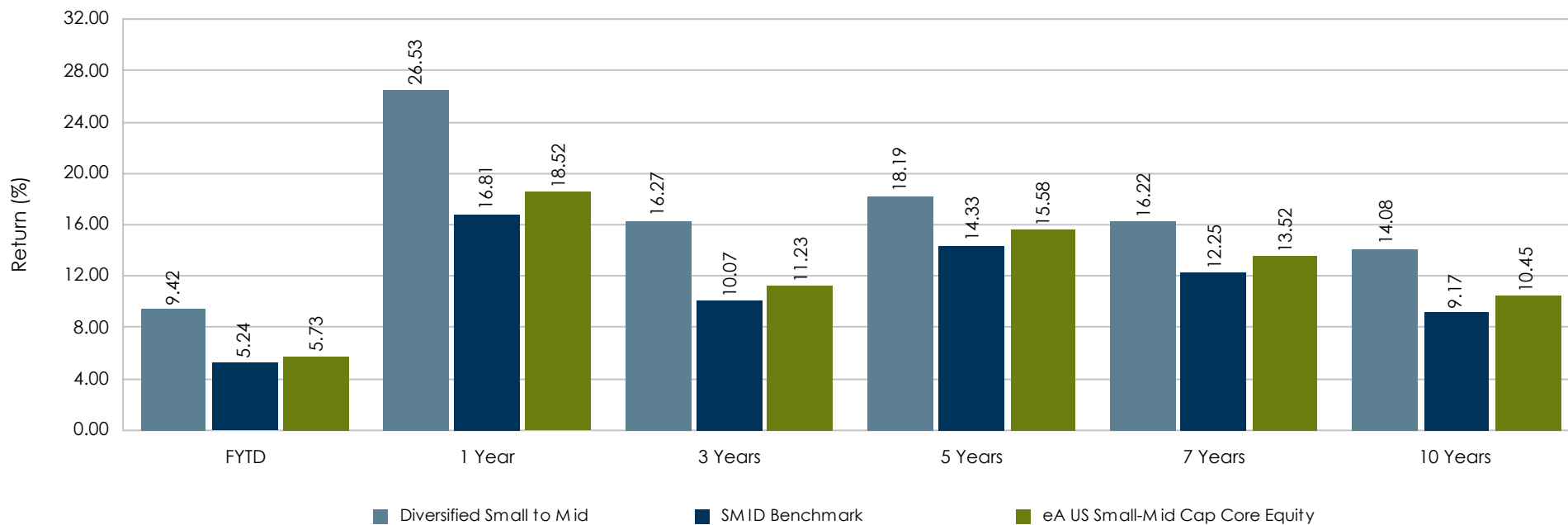


Sector Allocation

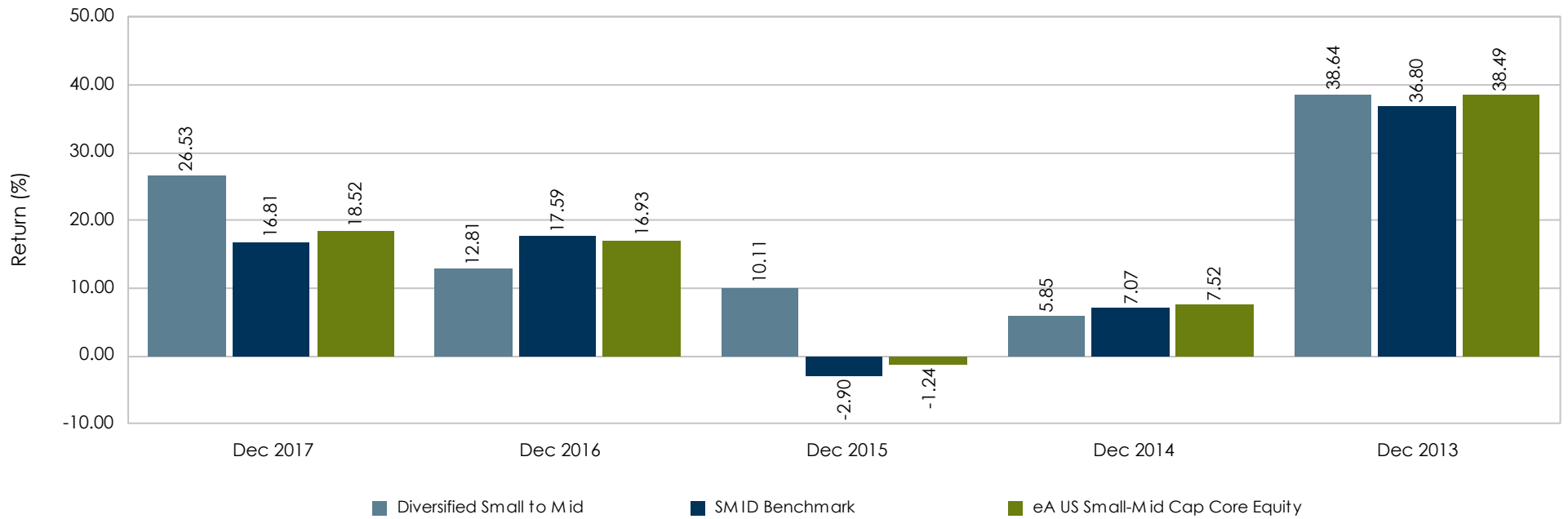
