Quick Survey Series – COVID-19 Emergency Declarations, Ordinances & Proclamations

The Center for Municipal Research conducted a survey of the 412 municipalities in Florida in response to a request from the Office of the Governor, the Division of Emergency Management and the Department of Health regarding municipal actions to help prevent the spread of the COVID-19 virus. The survey was conducted electronically from March 24-26, 2020, with a response rate of 80% or 330 cities.

(This is a snapshot of activities based on recommendations and requirements current for the timeframe surveyed. This is a fluid situation and policies may change frequently to adapt to citizen needs.)

Key Take-Aways

(Important Note: Survey questions refer to specific formal adoptions of declarations; however, cities may adopt recommendations, etc. at their discretion based on state and federal recommendations or local emergency orders without a formal policy being put in place. Many cities are following recommendations and emergency declarations made by their counties, and did not adopt formal declarations of their own, and are therefore not reflected in the survey results. Please see the additional comments section of this document or contact the individual cities for specifics of the emergency orders they are following.)

Of municipalities who responded:

- 83% of cities have closed their city hall to the public 72% completely and 11% have developed modified procedures to deal with the public in a limited capacity, such as by appointment only, in response to COVID-19.
- 71% of cities have adopted a local emergency declaration or order in response to COVID-19.
- Nearly half of all cities have adopted or issued proclamations or ordinances regarding the use of public facilities in response to COVID-19. The most common regard park closures (34% of cities), beach closures (16%) and social distancing recommendations (14%). Most other cities are following county closure orders.
